Abstract: The Arab-American community lies at the nexus of intersecting lines of political power, and is subject to pervasive discursive misrecognition, that is, the limiting of members' ability to act as persons capable of taking any position in ongoing social and political discourses. Engaging seriously with Arab-American political discourses is a critical political-ethical task for the non-Arab American political community. I argue that taking Arab-American political discourse seriously undermines three commonly-held positions about the community: that they are apolitical, that they are 'just like' any other American ethnic community, or that they are entirely alien to the American political experience. This dissertation develops a detailed analysis of political discourse in Arab New York around three important social fields: education, particularly community-driven educational programming; Palestine, particularly two major pro-Palestinian activist gropes; and gender, particularly the experiences of young women with social surveillance.
